#### LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY (LDEQ) OCCIDENTAL CHEMICAL CORPORATION-TAFT PLANT DRAFT WATER DISCHARGE PERMIT

The LDEQ, Office of Environmental Services, is accepting written comments on a draft Louisiana Pollutant Discharge Elimination System (LPDES) permit prepared for Occidental Chemical Corporation, Taft Plant, 266 Highway 3142, Hahnville, Louisiana 70057. The facility is located at 266 Highway 3142 in Hahnville, St. Charles Parish. Upon the effective date of the final permit, the LPDES permit shall replace the previously issued LPDES permit.

This facility is subject to Section 316(b) of the Clean Water Act and the applicable Federal and State regulations for cooling water intake structures. This draft permit includes conditions towards compliance with these regulations.

The principal discharge from this existing source is made into the Mississippi River (Outfalls 001 and 002) and St. Charles Canal (Outfalls 003, 004, and 005), waters of the state classified for primary contact recreation, secondary contact recreation, fish and wildlife propagation, and drinking water supply (Mississippi River only). Under the SIC Codes 2812 and 4911, the applicant proposes to discharge treated process wastewater, miscellaneous wash waters, process area stormwater, brine processing wastewater, chlorine condensate, cell renewal wastewater, caustic evaporation wastewater, laboratory wastewater, pump and process seal water, hydrostatic test waters, cooling tower blowdown, utility condensate, sulfate purge wastewater, treated groundwater remediation wastewater and process area stormwater from the renovation area, treated sanitary wastewater, wastewaters associated with the co-generation facility operations, non-process area stormwater, and vehicle rinse water (Outfall 001); river clarifier water, sludge, and filter and softener backwash (Outfall 002); and low contamination potential stormwater (Outfalls 003, 004, and 005) from an existing chlor-alkali manufacturing facility.

During the preparation of this permit, it has been determined that the discharge will have no adverse impact on the existing uses of the receiving waterbody. As with any discharge, however, some change in existing water quality may occur.

#### LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY (LDEQ) ST. CHARLES PARISH COUNCIL - LULING OXIDATION POND DRAFT WATER DISCHARGE PERMIT

The LDEQ, Office of Environmental Services, is accepting written comments on a draft Louisiana Pollutant Discharge Elimination System (LPDES) permit prepared for St. Charles Parish Council, Luling Oxidation Pond, P.O. Box 302, Hahnville, Louisiana 70057. The facility is located at 199 Texas Road in Luling, St. Charles Parish. Upon the effective date of the final permit, the LPDES permit shall replace the previously issued LPDES permit.

The principal discharge from this existing source is made into the Luling Wetlands, waters of the state classified for secondary contact recreation and propagation of fish and wildlife. Under the SIC Code 4952, the applicant proposes to discharge treated sanitary wastewater from a publicly owned treatment works serving the communities of Luling, Reotte, Willowick, Willow Ridge, Monona, Lakewood, and Davis Plantations.

During the preparation of this permit, it has been determined that the discharge will have no adverse impact on the existing uses of the receiving waterbody. As with any discharge, however, some change in existing water quality may occur.

Comments and requests for a public hearing or notification of the final decision can be submitted via personal delivery, U.S. mail, email, or fax. **Comments and requests for public hearings must be received by 4:30 pm CST, Thursday, September 8, 2016.** Delivery may be made to the drop-box at 602 N. 5<sup>th</sup> St., Baton Rouge, LA 70802.
